## Survey background

In 2018, the Los Angeles Regional Adult Education Consortium conducted a governance survey that focused on a sampling of the state's 71 adult education consortia. This research inspired the California Adult Education Program to find out what the statewide governance picture looked like to create a resource for consortia considering changes to their governance structure. The intent is that the information in this report, and the individual-response file that accompanies it, will serve as a valuable, time-saving resource to help you more quickly identify and connect with consortia that can best provide guidance and wisdom applicable to your situation. In addition, the information shared via the survey will help the California Adult Education Program with the process of reviewing consortium bylaws for adult education consortia throughout the state to ensure compliance with state requirements.




#### **Number of Consortium Members**


What is your consortium's funding structure?

Which types of governance documents does your consortium have, in addition to CFAD?








#### **Dedicated Staff**

Does your consortium have dedicated staff to work on consortium-level activities?








#### **Employers of Dedicated Staff**


If your consortium has dedicated staff, who is their employer?





#### **Governing Body Structure**


What is the structure of the governing body for your consortium?





## Frequency of Meetings


How often do your members meet to conduct consortium business?





## Decision-Making Model


What decision-making model does your region use?





## **Assigned Votes**


How are votes assigned to your members?


Who are the active participants in your consortium work?


Who are your voting members?


Does your region use work groups?

How are your work groups or committees organized?


